80402 Trust Receipt Acceptance

The President is authorized to accept, in lieu of actual physical possession of security offered as collateral, Trust Receipts offered as collateral for investment of temporary idle funds. Trust Receipts may be accepted from or held on deposit with any Federal Reserve Bank or with the trust department of a state or federally chartered bank other than the bank offering the collateral.
