


To access **Business Source Elite** go to the MCC library website, click on the **Databases** tab, then use the **Databases by Title** menu to select **Business Source Elite**.



12. You can also add **additional terms** in the other search boxes to focus your search.

The word **AND** instructs the database to find records containing both of your search terms. In the example below, the database will retrieve articles about Buffalo Wild Wings that also contain the word **sales**.
